- ◆ 關係企業間交易依據常規交易原則,並遵循經濟合作暨發展組織(OECD)所公布 移轉訂價指導原則。
 - Inter-company transactions are based on the Arm's Length Principle and follow the Transfer Pricing Guidelines issued by the Organization for Economic Co-operation and Development (OECD).
- ◆ 避免以不當避稅為目的將交易活動移轉到無實質營運的低稅率國家或避稅天堂。 Avoid shifting transactions to low-tax jurisdictions or tax havens without substantial operating business for the purpose of improper tax avoidance.
